ORDER:

In the Government Order first read above, the 'Best Practices Award' was instituted to reward those who have achieved excellent results in good governance and successfully implemented strategies, new initiatives and best practices. The award carries a cash reward of Rs.2.00 lakhs each for three chosen nominations.

2. Nominations for the Best Practices Award are received under three categories, viz., (i) Government employees – individual; (ii) Government employees – as a group; and (iii) Organisation / Institution / Office.

3. For the year 2018, 26 (twenty six) nominations were received and the Screening Committee for the award in its meeting held on 30.07.2018 under the Chairmanship of Additional Chief Secretary to Government, Finance Department scrutinised the nominations and has recommended 12 (twelve) nominations. The 12 (twelve) nominations recommended by the Screening Committee were placed before the Selection Committee in its meeting held on 03.08.2018 under the Chairmanship of Chief Secretary to Government. The Selection Committee scrutinised the nominations for the "Best Practices Award" under the categories of 'Individual' and 'Organisation'. The Committee after detailed deliberations decided to recommend the following three nominations for the Best Practices Award-2018.

i.	Registration Department for "providing speedy registration and online services to public through 'Star 2.0', a web based software"
ii.	Civil Supplies and Consumer Protection Department for "end to end computerization of Public Distribution System"
iii.	State Health Society for implementation of "TAEI – Tamil Nadu Accident and Emergency Care Initiative"

4. The Selection Committee has also recommended that as a token of appreciation of the special initiatives taken by Thiru. Bandi Gangadhar, IPS., in having implemented "5-S – Work Place Management System in Dharmapuri District Police Establishments" as Superintendent of Police, Dharmapuri District and Thiru R. Subramanian in having substantially contributed for the settlement of various Inter-State River Water issues as Chairman, Cauvery Technical Cell, a Certificate of Appreciation to each of them may be given by the Hon'ble Chief Minister. Further, the Committee has recommended that the Cauvery Technical Cell may also be given a Certificate of Appreciation for its contribution in the settlement of various Inter-State River Water issues by the Hon'ble Chief Minister.

5. Based on the recommendations of the Selection Committee and after careful examination of the nominations, Government have decided that the 'Best Practices Award-2018' be given to the following three initiatives recommended by the Selection Committee and the details of awardees who shall receive the reward amount of Rs.2,00,000/- each are as follows:

The award certificate together with a cheque for an amount of Rs.2,00,000/- (Rupees two lakhs only) for three awardees shall be presented by the Hon'ble Chief Minister during the Independence Day–2018 celebrations.

Subramanian for his contribution in the settlement of various Inter-State River Water issues as Chairman, Cauvery Technical Cell.
